AGREEMENT TO CHECK DRIVING LICENCES

The Hirer: Welsh Parliament/Senedd Cymru N0003

We hereby agree to the following:

1. In consideration for Days Rental (any branch) providing us with rental facilities under our rental contract, we hereby agree to check the validity of the driving licences of each and every employee who will drive a vehicle supplied by Days Rental. We agree to check their entitlement to drive a motor vehicle of the class supplied by Days Rental. We acknowledge that our obligations under this letter are necessitated for the purposes of Days Rental's insurance cover of the vehicles provided under the rental contract.
2. We will ensure that any driver using the vehicle(s) will hold and not have been disqualified from holding or obtaining a full UK driving licence valid for relevant vehicle(s).
3. We will ensure that the driver will meet the following criteria:-
 - Over the age of 25 years and under the age of 75 years
 - Held a full UK licence for a minimum of two years
 - Have no driving convictions within the previous five years, with the exception of no more than two Fixed Penalty Speeding Offences of three penalty points each which are acceptable
 - Have no accidents or motor claims within the previous five years
 - Have no medical conditions that warrant declaration to the DVLA
 - Occupation will not be: Foreign Servicemen based in UK, Foreign students, connected to gambling or betting, Professional Sportspersons / Entertainers, Traders - of no fixed abodeAny driver that does not meet this criteria must not drive any vehicle unless written approval is obtained from Days Rental.
4. We will ensure the vehicle will not be used for any of the following purposes:-
 - Carriage of Passengers for Hire and Reward e.g. Chauffeur Drive & Private Hire
 - Use as a taxi, Driving School use etc.
 - Racing, Pacemaking Trials, Speed Testing
5. We will ensure that any accident or claim will be reported to Days Rental by completion of an accident report form to be supplied on request from Days Rental.
6. We agree that in the event of any accident or claim the driver's licence/driving record will be made available to Days Rental.
7. We agree that the hirer will be responsible for the theft of the vehicle in the event that the keys are not removed and/or the vehicle has not been locked.
8. In the event of any act or omission or breach of this agreement on the part of the hirer that shall cause the insurers of Days Rental to deem that the driver would not have been accepted to drive under the policy, we agree to fully indemnify Days Rental and their insurers against all costs, including any third party claims, arising from any claim.
9. We understand failure to carry out adequate checks on the driving licence (s) of our employee(s) could result in prosecution under the Road Traffic Act or associated relevant legislation.

This document forms part of the rental contract. It is understood that the conditions in this document apply to all rental contracts with which insurance cover is provided by Days Rental.
